THIS MATTER now coming before the Board of County Commissioners of Lane County and Martin A. Myhre and Carol L. Myhre, husband and wife, owning land within Lane County which is outside the limits of an incorporated city, having on this day presented to the Board of County Commissioners of Lane County a good and sufficient dedication, said dedication being properly executed and forever dedicating a portion of such land to the use of the public for road purposes and granting a public road easement, and the Board of County Commissioners of Lane County deeming it proper, as a convenience for property owners in the area and as a benefit to the general public, to accept said dedication for a public road easement;

NOW, THEREFORE, IT IS HEREBY ORDERED that the said dedication shall be and is hereby accepted by the Board of County Commissioners of Lane County as a public road easement; and

IT IS FURTHER ORDERED that the described right-of-way is expressly accepted as a County Road by this Order; and

IT IS FURTHER ORDERED that the above Order shall be entered in the records of the Board of County Commissioners' Journal of Administration and in the road records for County Road Number 323 in the regular numbered road files in the County Surveyor's Office; and

IT IS FURTHER ORDERED that the dedication be recorded in the Deed Records of the County and the Document Number be noted on this Order.

DEDICATION OF A PUBLIC ROAD EASEMENT

Martin A. Myhre and Carol L. Myhre, husband and wife

GRANTORS, grant and dedicate to **LANE COUNTY**, a political subdivision of the State of Oregon (**GRANTEE**) a public road easement on and over the following described property:

A parcel of land lying in the Northwest one-quarter (NW ¼) of Section 9, Township 18 South, Range 5 West of the Willamette Meridian, and being a portion of the tract of land conveyed to **MARTIN A. MYHRE** and **CAROL L. MYHRE**, husband and wife, by that certain Warranty Deed recorded on Reel 660-R, Reception Number 7346944, Lane County Oregon Deed Records, said parcel being described as follows:

Beginning at a 5/8" iron rod with cap marked "EGR & ASSOC." on the east-west quarter section line of said Section 9 as established in CSF 9466 said point is S89°43'15"E 874.37 feet from the west quarter corner of said Section 9; thence S89°43'15"E 41.64 feet to the centerline of Central Road, County Road Number 323; thence N16°26'24"E along the centerline of Central Road 318.93 feet; thence N89°43'15"W 41.64 feet to a 5/8" iron rod with cap marked "EGR & ASSOC."; thence S16°26'24"W 318.93 feet to the POINT OF BEGINNING, and there ending, all in Lane County, Oregon.

The bearings used herein are based upon a Partition Plat for Martin & Carol Myhre, to be filed as a survey in the Office of the Lane County Surveyor.

It being the intent herein to acquire right-of-way for Central Road (County Road Number 323) which, with this dedication, will result in a right-of-way width of 40.0 feet from centerline as said road extends through the GRANTOR'S property.

There is no consideration for this dedication.

Said parcel being forever dedicated to the use of the public for road purposes and granting a public road easement.

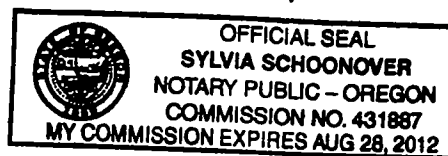

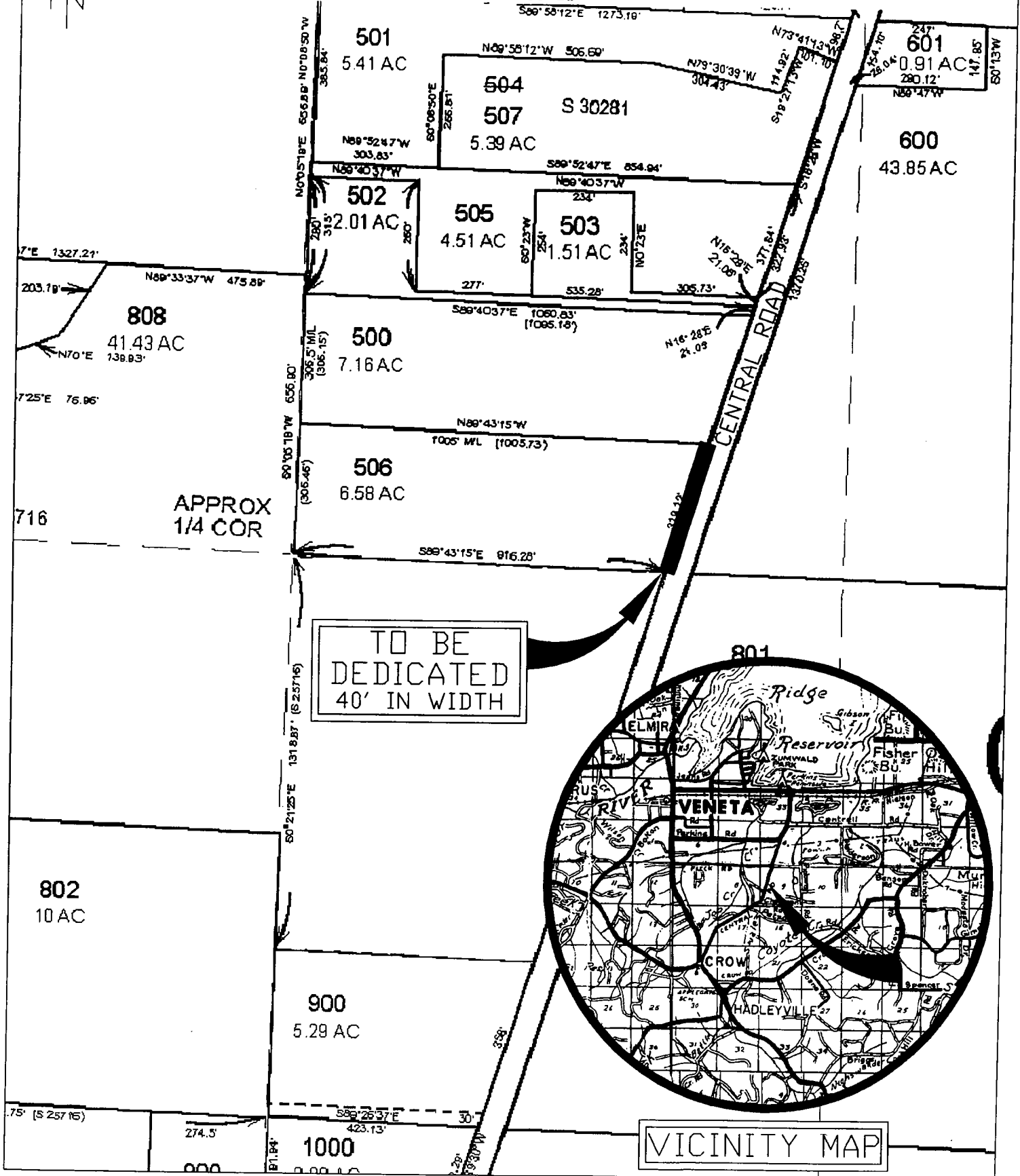

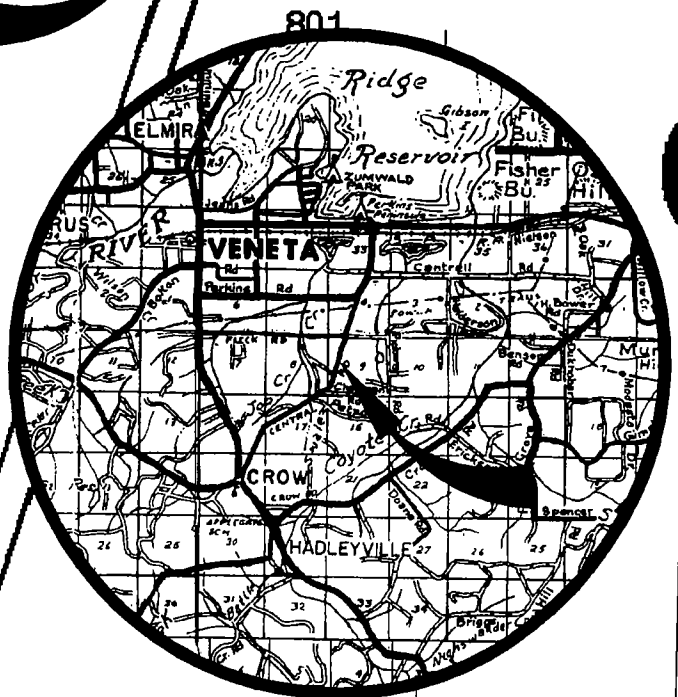
