ORDER 98-7-14-1) IN THE MATTER OF AMENDING BOARD ORDER 98-06-24-33, WHICH ADOPTED THE FY 98-99 BUDGET, TO REDUCE THE AMOUNT OF TAXES THAT WILL BE LEVIED BEGINNING JULY 1, 1998

WHEREAS, Board Order 98-06-24-33 was the resolution and order which adopted the Fiscal Year 1998-1999 budget for the year beginning July 1, 1998; and

WHEREAS, this Board Order set the amount of taxes to be levied as two separate rates, \$1.2793 per \$1,000 of assessed value for operations, \$1.0000 per \$1,000 for a local option Public Safety Levy, and the amount of \$2,864,184 for bonds; and

WHEREAS, the \$1.0000 per \$1,000 was a placeholder for a local option serial levy in the event the Public Safety Coordinating Council (PSCC) and the Board of Commissioners decided to put a public safety levy on the September ballot; and

WHEREAS, it is now clear the PSCC has dropped the September election and will instead be recommending a November ballot, changing the availability of the funds from FY 98-99 to FY 99-00 and thereby removing the necessity for the separate rate; now therefore,

IT IS HEREBY ORDERED that the section of Board Order 98-06-24-33 that sets the tax levy, its allocations and categorizes the taxes is amended to read:

ORDERED that the Board of Commissioners of Lane County hereby levies the taxes provided for in the FY 98-99 adopted budget at the rate of \$1.2793 per \$1,000 of assessed value for operations, and the amount of \$2,864,184 for bonds, and that these taxes are levied upon all taxable property within the County as of 1:00 a.m. July 1, 1998.

The following allocation and categorization subject to the limits of section 11b, Article XI of the Oregon Constitution make up the above tax levies:


