ORDER 96-3-13-1

IN THE MATTER OF APPOINTING FOUR MEMBERS TO THE PUBLIC SAFETY COORDINATING COUNCIL AND AMENDING LANE MANUAL CHAPTER 3 TO INCREASE MEMBERSHIP (LM 3.522)

WHEREAS, the State Legislature adopted SB 1145 (1995 OR. Laws, Ch. 423) and directed the creation of public safety coordinating councils in the various counties throughout the state, charging these councils with responsibility for system-wide community safety and justice planning, and

WHEREAS, Lane County established a Public Safety Coordinating Council, and

WHEREAS, Lane County adopted an interagency agreement with the Cities of Eugene and Springfield to provide a cooperative and balanced approach to the justice system in Lane County, and

WHEREAS, this agreement specified additional designated seats on the Public Safety Coordinating Council from both Cities, now, therefore, the Board of Commissioners of Lane County orders:

that the following representatives be appointed to fill designated seats on the Public Safety Coordinating Council as follows:
