ORDINANCE NO. PA 1082

) IN THE MATTER OF RENAMING CRIMSON
) COURT, ECLIPES COURT, GILHAM COURT
) NUMBER ONE AND GILHAM COURT NUMBER
) TWO TO GILHAM ROAD.

WHEREAS, Crimson Court is County Road Number 1747, Eclipses Court is County Road Number 1748, Gilham Court No. 1 is County Road Number 1750 and Gilham Court No. 2 is County Road Number 1752 and all four roads are outside the City Limits of the City of Eugene but are within the Urban Growth Boundary of the City of Eugene, Lane County has jurisdiction for the renaming of these roads; and

WHEREAS, it is in the public interest for the four above named roads to be renamed to Gilham Road; and

WHEREAS, the Lane County Surveyor's Office has received a valid application from the City of Eugene requesting that the four roads be renamed to Gilham Road to provide continuity of addressing for emergency services; and

WHEREAS, authority was granted to Lane County by ORS Chapter 215, Lane Code Chapter 15 and the Lane County Home Rule Charter regarding procedures and requirements relating to the naming and renaming of roads in Lane County; and

WHEREAS, legal notice has been provided by publication, posting and service to abutting owners, in accordance with Lane Manual 15.025; and

WHEREAS, on May 1, 1996, the Lane County Board of Commissioners conducted the First Reading of the Ordinance, and on June 12, 1996, conducted the Second Reading and held a public hearing to consider the road renaming ordinance;

NOW THEREFORE, the Board of County Commissioners of Lane County ordains as follows:

- 1. That the four roads as described above and as shown on Attachment "A" are to be renamed Gilham Road.

If any subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions.
