**ORDER AND RESOLUTION 96-10-30-20 IN THE MATTER OF APPROVING A GRANT AWARD FROM OREGON DEPARTMENT OF STATE POLICE FOR TREATMENT OF VIOLENT OFFENDERS, ESTABLISHING WITHIN THE DEPARTMENT OF YOUTH SERVICES A 1.0 FTE JUVENILE COUNSELOR 2 POSITION, APPROPRIATING TO THE BUDGET OF THE DEPARTMENT OF YOUTH SERVICES SPENDING AUTHORITY IN THE AMOUNT OF \$165,001, AND AUTHORIZING THE COUNTY ADMINISTRATOR TO EXECUTE THE GRANT AWARD CONDITIONS AND CERTIFICATIONS AGREEMENT.**

WHEREAS, Lane County has responsibility for juvenile corrections within the borders of the County, and;

WHEREAS, Lane County is resolved to protect its residents and visitors from the threat of violent crime, including crime committed by juveniles; and

WHEREAS, the State of Oregon has awarded to Lane County \$165,001 to assist in Lane County's effort to eliminate violent juvenile crime; and

WHEREAS, the Board of County Commissioners as the governing body of Lane County may, as provided in ORS 294.326(2) appropriate by resolution unanticipated revenues and expenditures;

NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED that within Fund 24 for FY 96-97;


- (1) \$165,001.00 in revenue and expense is appropriated to the budget of the Department of Youth Services; and
- (2) A new 1.0 FTE Juvenile Counselor 2 position is established within the Department of Youth Services; and
- (3) The County Administrator is delegated authority to execute the Grant Award Conditions and Certifications agreement for the Violent Offender Rehabilitation Treatment program.


