WHEREAS, Plan/Amendment Approval Form 23 forwarded \$2,693,094 in funds and services for Employment/Alternatives to Employment Services; and

WHEREAS, a competitive process was completed to identify service providers per Lane Manual 21.270, and

WHEREAS, the County Administrator signed for acceptance of PAAF 23, and the Board of County Commissioners appropriated \$2,693,094 in revenue and expenses in fund 86 per Board Order 96-6-19-1; now therefore it is hereby
