**THIS MATTER** now coming before the Board of County Commissioners of Lane County and Claude Hensley (deceased) and Juanita Hensley, owning land within Lane County which is not within the limits of an incorporated city or town, having on this day presented to the Board of County Commissioners of Lane County a good and sufficient deed, said deed being properly executed and forever dedicating a portion of such land to the use of the public for road purposes and granting a public road easement and the Board of County Commissioners of Lane County deeming it proper, as a convenience for property owners in the area and as a benefit to the general public, to accept said deed for a public road easement;

**NOW, THEREFORE, IT IS HEREBY ORDERED** that the said deed shall be and is hereby accepted by the Board of County Commissioners of Lane County as a public road easement; and

**IT IS FURTHER ORDERED** that the described right-of-way be expressly accepted as County Road by this Order; and

**IT IS FURTHER ORDERED** that the above Order shall be entered in the records of the Board of County Commissioners' Journal of Administration and in the road records for County Road Number 2008 in the regular numbered road files in the County Surveyor's Office; and

**IT IS FURTHER ORDERED** that the deed be recorded in the Deed Records of the County and the Instrument Number be noted on this Order.

## DEDICATION OF A PUBLIC ROAD EASEMENT

**CLAUDE HENSLEY(deceased) and JUANITA HENSLEY, husband and wife**

**GRANTORS**, grant and dedicate to LANE COUNTY, a political subdivision of the State of Oregon (GRANTEE) a public road easement on and over the following described property:

A parcel of land lying in the Southwest one-quarter (SW ¼) of Section 9, Township 21 South, Range 3 West of the Willamette Meridian, and being a portion of the tract of land acquired by Claude Hensley (deceased) and Juanita Hensley, by a certain Warranty Deed recorded on Reel 484-R, Recorder's Reception Number 10222, Lane County, Oregon, Deed Records, said parcel being more particularly described as follows:


Beginning at the Brass Cap monument marking the Southwest corner of the H.W. Taylor Donation Land Claim Number 46 in Section 16, Township 21 South, Range 3 West of the Willamette Meridian; thence North 3675.54 feet; thence East 35.31 feet to a 5/8 inch iron rod being the TRUE POINT OF BEGINNING; thence South 0°06'30" East 512.83 feet to a 5/8 inch iron rod; thence South 89°50'00" West 36.28 feet; thence North 512.93 feet; thence East 35.31 feet to the TRUE POINT OF BEGINNING, all in Section 9, Township 21 South, Range 3 West of the Willamette Meridian, in Lane County, Oregon.

It being the intent herein to acquire right-of-way for London-Latham Road (County Road Number 2008) which, with this dedication, will result in a right-of-way width of 35 feet from centerline as said road abuts the GRANTOR'S property.

There is no consideration for this dedication.

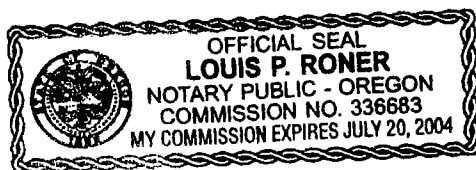
Said parcel being forever dedicated to the use of the public for road purposes and granting a public road easement.
