On June 24, 1980, by Ordinance 11-80 effective July 24, 1980, the Board amended Chapter 10 of the Lane Code by adding procedures for establishing Planning Director Review, Hearings Official Review and Planning Commission Review of specified uses, adding and revising certain definitions and revising authority to charge fees for certain application processes, but at the time of enactment of Ordinance 11-80, the pages attached thereto were not in Code format.

The Board of County Commissioners of Lane County ordains as follows:


