ORDINANCE NO. PA 916

(IN THE MATTER OF ADOPTING
(THE EUGENE-SPRINGFIELD
(METROPOLITAN AREA PUBLIC
(FACILITIES PLAN

WHEREAS, the Administrative Rule on Public Facility Planning (OAR 660 Division 11) carries out the legislative requirement that cities and counties "shall develop and adopt a public facilities plan for areas within an urban growth boundary containing a population greater than 2,500 persons"; and

WHEREAS, the Metropolitan Plan requires the elected officials of the three metropolitan governments to ratify functional plans that serve as supplements to the Metropolitan Plan; and

WHEREAS, in September 1984, a work program for the 2-2 1/2 Year Mid-Period Review of the Metropolitan Plan was adopted by the Metropolitan Policy Committee (MPC), and that listed the Public Facilities Plan as one of its products; and

WHEREAS, the Metropolitan Area Planning Advisory Committee (MAPAC) reviewed and approved the proposed Public Facilities Plan on April 17 and May 1, 1986; and

WHEREAS, the Metropolitan Policy Committee (MPC) reviewed and approved the proposed Public Facilities Plan on June 3, 1986; and

WHEREAS, the Eugene and Lane County Planning Commissions conducted a joint public hearing on the Public Facilities Plan on April 15, 1986; and

WHEREAS, in accordance with the Post Acknowledgement plan review procedures of ORS 197.610 - .650, the proposed Public Facilities Plan was transmitted to the Department of Land Conservation and Development on June 17, 1986; and

WHEREAS, the Lane County Planning Commission held a public hearing on December 2, 1986, and recommended adoption of the proposed Public Facilities Plan with revisions.

WHEREAS, the Lane County Board of Commissioners at a work session on March 3, 1987 recommended that the proposed Ordinance be modified further; and

WHEREAS, the Lane County Board of Commissioners held a public hearing on this matter; NOW

THEREFORE, the Board of County Commissioners of Lane County Ordains as follows:

1. that the Lane County Board of Commissioners hereby adopts the Eugene-Springfield Metropolitan Area Public Facilities Plan, attached

as Exhibit 'A', and incorporating the changes attached as Exhibit 'B', 'C', and 'D'.

2. the discussion and findings included in Exhibits 'A', 'B', 'C', and 'D' are adopted as findings in support of this ordinance.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not effect the validity of the remaining portions hereof.
