WHEREAS, AT A DULY PUBLICIZED TIME AND PLACE ON FEBRUARY 7, 1991, ROGER BRASSFIELD OF THE HOUSING AUTHORITY AND COMMUNITY SERVICES AGENCY OF LANE COUNTY, OREGON, OPENED BIDS ON THE FOLLOWING PROJECT:

TO SUPPLY LABOR AND MATERIALS TO INSTALL CARPET, VINYL AND COVE BASE IN ALL RESIDENTIAL UNITS, AND SECURE THE FLOORING IN THE SECOND STORY UNITS AT LINDBORG PLACE, JUNCTION CITY, OREGON. THAT AN ORDER TO THIS EFFECT BE SIGNED; AND AN AGREEMENT BE EXECUTED IN ACCORDANCE WITH BID DOCUMENTS.

WHEREAS, HUD APPROVAL IS NECESSARY AS A REQUIREMENT OF THE MODERNIZATION PROGRAM; AND

WHEREAS, FUNDS ARE AVAILABLE TO FINANCE THE PROJECT, AND THE EXECUTIVE DIRECTOR HAVING SO RECOMMENDED, NOW, THEREFORE, IT IS HEREBY

ORDERED, THAT SUBJECT TO HUD APPROVAL, THE CARPET COMPANY BE AWARDED CONTRACT # 91-C-0012 FOR THE SUPPLY AND INSTALLATION OF CARPET, VINYL AND COVE BASE IN THE AGENCY-OWNED RESIDENT UNITS AT LINDBORG PLACE, JUNCTION CITY, OREGON AND THAT THE AGREEMENT BE EXECUTED BY THE EXECUTIVE DIRECTOR IN ACCORDANCE WITH THE BID DOCUMENTS. THE CONTRACTOR SHALL PRESENT A VALID SIGNED CONTRACT WITH PERFORMANCE SECURITY IN THE FULL AMOUNT OF \$ 34,250.00 AND SHALL SATISFACTORILY COMPLETE ALL WORK WITHIN THE SPECIFIED CONTRACT TIME.
