WHEREAS, the Board of County Commissioners has accepted revenues pursuant to the 1993-95 Intergovernmental Agreement #20-001 with the State Mental Health and Developmental Disability Services Division; and

WHEREAS, Amendment #6 increases the spending limitation in Lane County for developmental disability services; and

WHEREAS, Plan/Amendment Approval Form #25 increases the payment amounts to award a 3.2 percent cost-of-living adjustment for services for individuals with developmental disabilities as defined and funded by the 1993-95 Intergovernmental Agreement; and

WHEREAS, Lane County must use those revenues through its administrative agent the Department of Health and Human Services; and

WHEREAS, the Board of County Commissioners as the governing body of Lane County may, in accordance with Oregon Revised Statute 294.326(2), appropriate by resolution unanticipated revenues and expenditures; now therefore it is hereby

ORDERED that the Board of County Commissioners accept Amendment #6 and Plan/Amendment Approval Form #25 to the 1993-95 Intergovernmental Agreement #20-001 with the State Mental Health and Developmental Disabilities Services Division; and further

ORDERED that the Board of County Commissioners delegate authority to the County Administrator to sign Amendment #6 and the Plan/Amendment Approval Form #25; and further

RESOLVED AND ORDERED that the Board of County Commissioners increase the fiscal year 1993-94 budget for the Department of Health and Human Services by the increase in appropriations in Fund 24 of \$299,693.21 in revenues and expenditures.
