WHEREAS , the Regional Strategies Program was established by the Governor and the Legislature to strengthen regional economies and retain, increase, or lead to an increase in the number of family wage jobs in the state of Oregon; and

WHEREAS, the Lane County Board of Commissioners in Order No. 93-10-27-14 requested that Lane County be designated a Region with Benton, Lincoln and Linn Counties under the Oregon Regional Strategies Program, and on November 3, 1993, the Oregon Economic Development Department designated the Benton-Lane-Lincoln-Linn Region to prepare a six-year economic development Strategy focusing on the development of two or three key industries; and

WHEREAS, the Lane County Board of Commissioners in Order No. 93-11-30-2 appointed five Lane County members and accepted the fifteen members appointed by Benton, Lincoln, and Linn Counties to the Regional Strategy Board with majority representation primarily from the private sector; and

WHEREAS, the Region, through its appointed Regional Board, has developed a six-year economic development Strategy for the Benton-Lane-Lincoln-Linn Region focusing on developing the key industries of High Technology, Software, and Forest Products; and

WHEREAS, the Lane County Board of Commissioners has reviewed the draft Regional Strategy and finds that it meets the requirements of the Regional Strategies Program, including having the Regional Board members holding a public hearing on the Region's Strategy in each county of the Region;

NOW, THEREFORE, IT IS HEREBY RESOLVED that the Lane County Board of Commissioners adopts the Region's Strategy and recommends that the Strategy be submitted to the Oregon Economic Development Commission and the Governor of the State of Oregon for consideration under the Regional Strategies Program; and FURTHER RESOLVED that the Lane County Board of Commissioners hereby commits to coordinating efforts with the governing bodies of Benton, Lincoln and Linn Counties to take any action necessary to ensure that the Region achieves its goals as set forth in the Region's Strategy.
