WHEREAS, on January 12, 1994 the Board of County Commissioners ordered the question of the formation of the Fern Ridge Library District be referred to the voters for election and further that an election be held for the first members of the five-member district board, and

WHEREAS, on May 17, 1994 said election was duly held, and

WHEREAS, the Chief Deputy County Clerk has certified the results of said election to the Board of County Commissioners, now, therefore, it is hereby

ORDERED AND PROCLAIMED that:

1. The number of votes cast for and against the question of the formation of the Fern Ridge Library District are as set forth in the attached Certificate of the Chief Deputy County Clerk, marked Exhibit "A", attached hereto and incorporated by this reference.

2. The Fern Ridge Library District, as described in Exhibit "B", attached hereto and incorporated by this reference, is hereby created in accordance with Oregon law (ORS 198.820) and shall, as of the date of this Order, be a municipal corporation formed for the purpose of providing library services and facilities in accordance with ORS Ch 357, and shall be known as the Fern Ridge Library District, and as such, shall have perpetual succession.

3. The initial tax base for the Fern Ridge Library District is \$150,000.

4. The Board of County Commissioners finds and declares the following individuals to be the first members of the District Board:

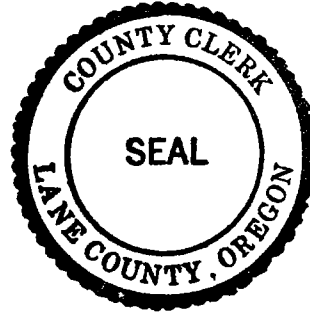

Hinton Donation Land Claim No. 37, Township 17 South, Range 5 West and South 40° 45' West 1054 feet from said Northeast line; thence south 46° 15' East to Southeast corner said Hinton Donation Land Claim; thence North 40° 45' East 14.18 chains to Northwest corner of Benjamin Richardson Donation Land Claim No. 42; thence east along north line of said Donation Land Claim No. 42 and said line produced, to west line of section 3, Township 17 South, Range 5 West; south to the Southwest corner of Block 1 of 2nd Amended Plat of Fern Ridge, Which point is 2358 feet South 0° 29' East of the Northwest corner of said section 3; thence east to
