WHEREAS, the Board of County Commissioners has accepted revenues pursuant to the 1993-95 Intergovernmental Agreement #20-001 with the State Mental Health and Developmental Disability Services Division; and

WHEREAS, Plan Amendment Approval Form #50 increases the spending allocation to add \$1,335.26 for subcontracted services and \$21,839 for reimbursement of administrative costs for services to individuals with developmental disabilities as defined and funded by the 1993-95 Intergovernmental Agreement; and

WHEREAS, Lane County must use those revenues through its administrative agent the Department of Health and Human Services; and

WHEREAS, the Board of County Commissioners as the governing body of Lane County may, in accordance with Oregon Revised Statute 294.326(2), appropriate by resolution unanticipated revenues and expenditures; now therefore it is hereby


ORDERED, that the Board of County Commissioners accept Plan/Amendment Approval Form #50 to the 1993-95 Intergovernmental Agreement #20-001 with the Oregon Mental Health and Developmental Disabilities Services Division; and further

ORDERED, that the Board of County Commissioners delegate authority to the County Administrator to sign PAAF #50; and further

RESOLVED AND ORDERED, that the Board of County Commissioners increase the fiscal year 1993-94 budget for the Department of Health and Human Services by the increase in appropriations in Fund 24 of \$23,174.26 in revenues and expenditures.
