WHEREAS, the Board of County Commissioners has accepted revenues pursuant to the 1993-95 Intergovernmental Agreement #20-001 with the State Mental Health and Developmental Disability Services Division; and

WHEREAS, Plan Amendment Approval Forms #90 and #92 request changes in services for individuals with developmental disabilities as defined and funded by the Agreement; and

WHEREAS, the changes in services result in an overall funding reduction; and

WHEREAS, Lane County must use and reduce revenues through its administrative agent the Department of Health and Human Services; and

WHEREAS, the Board of County Commissioners as the governing body of Lane County may, in accordance with Oregon Revised Statute 294.326(2), appropriate by resolution unanticipated revenues and expenditures; and

WHEREAS, the Board of County Commissioners has the authority per Oregon Revised Statute 294.435(6) to reduce appropriations following a public hearing which was held this date; now therefore it is hereby

ORDERED that the Board of County Commissioners accept Plan/Amendment Approval Forms #90 and #92 to the 1993-95 Intergovernmental Agreement #20-001 with the State Mental Health and Developmental Disabilities Services Division; and further

ORDERED that the Board of County Commissioners delegate authority to the County Administrator to sign PAAF #90 and PAAF #92; and further
