WHEREAS, Commissioner Jack Roberts, North Eugene District, resigned his position with the Lane County Board of Commissioners effective 12:00 midnight, the first day of January; and

WHEREAS, the Lane County Board of Commissioners has duly considered appropriate candidates to appoint to that position; and

WHEREAS, Bobby L. Green, Sr. fulfills the requirements for being a County Commissioner in that Bobby L. Green, Sr. has resided within the County for two years prior to this date, has been a resident within the district for two months prior to this date and is able to serve on a full-time basis.

NOW THEREFORE IT IS HEREBY ORDERED pursuant to the Lane County Home Rule Charter and ORS 236.210 that Bobby L. Green, Sr. be appointed to perform the duties of the office of Lane County Commissioner, Position No. 4, North Eugene District, effective January 5, 1995, to serve until the vacancy is filled by election and the then Commissioner-elect takes office in January, 1997; and

IT IS FURTHER ORDERED that an election be held to fill the vacancy for the remainder of the term for Position No. 4, North Eugene District, on the Lane County Board of Commissioners, at the next available primary and general election dates in the manner prescribed by state law for the conduct of nonpartisan nominations and elections.




