WHEREAS, on April 4, 1995, the Lane County Board of County Commissioners, through Resolution and Order No. 95-4-4-10, accepted a boating facility grant from the Oregon State Marine Board for boating improvements at Richardson Park on Fern Ridge Reservoir; and

WHEREAS, on April 25, 1995, Robert W. Keefer, Parks Manager, Lane County Department of Public Works, under authority of Lane Manual, Chapter 21, opened bids for a Moorage Facility at Richardson Park, Lane County Contract No. 94/95-PKS-01; and

WHEREAS, Oregon Woods Inc. submitted the low bid of \$32,583, and the Director of the Department of Public Works recommends that the bid be accepted; NOW THEREFORE BE IT

ORDERED that the bid received from Oregon Woods Inc. be accepted as recommended; and it is further

ORDERED that Oregon Woods Inc. be awarded a contract for a Moorage Facility at Richardson Park in the amount of \$32,583 in accordance with the bid specifications; and it is further

ORDERED that a contract be executed in accordance with this Order and the bid specifications provided that the contractor presents a Performance Bond for the full amount of the contract, prior to execution; and it is further

ORDERED that, following receipt of the contractor's Performance Bond, the County Administrator be authorized to sign the contract.
