) IN THE MATTER OF ACCEPTING AN INTERGOVERNMENTAL AGREEMENT WITH THE OREGON DEPARTMENT OF ADMINISTRATIVE SERVICES, CRIMINAL JUSTICE SERVICES SECTION IN THE AMOUNT OF \$120,000 AND ACCEPTING REVENUE IN THE AMOUNT OF \$5,000 FROM THE LANE COUNTY INTERAGENCY NARCOTICS ENFORCEMENT TEAM (INET) FOR THE LANE COUNTY DRUG COURT; AND DELEGATING AUTHORITY TO THE COUNTY ADMINISTRATOR TO SIGN AN INTERGOVERNMENTAL AGREEMENT WITH THE OREGON DEPARTMENT OF ADMINISTRATIVE SERVICES AND A SUBCONTRACT WITH ADDICTION COUNSELING AND EDUCATION SERVICES, INC.

WHEREAS, the Board of County Commissioners approved the submission of the original grant to the Edward Byrne Memorial Fund for a Drug Court in March 1994; and

WHEREAS, the original grant was awarded for October 1, 1994 through June 30, 1995; and

WHEREAS, the grant has been renewed for fiscal year July 1, 1995 though June 30, 1996 in the amount of \$120,000 by the Oregon Department of Administrative Services for the Edward Byrne Memorial Fund to continue the Drug Court in Lane County; and

WHEREAS, Lane County Department of Health and Human Services has received funding from Lane I.N.E.T. forfeiture in the amount of \$5,000 to continue the drug court; now therefore it is hereby

ORDERED that the Board of County Commissioners accept an Intergovernmental Agreement from the Oregon Department of Administrative Services in the amount of \$120,000 and revenue from Lane I.N.E.T. in the amount of \$5,000; and further


ORDERED that the Board of County Commissioners award a subcontract in the amount of \$160,000 to Addiction Counseling and Education Services, Inc. to provide drug outpatient treatment services to drug court clients July 1, 1995 through June 30, 1996; and further

ORDERED that the Board of County Commissioners delegate authority to the County Administrator to sign an Intergovernmental Agreement with the Oregon Department of

Administrative Services and the subcontract with Addiction Counseling and Education Services, Inc.


