WHEREAS, Lane County is a participating county in the Community Corrections Act; and

WHEREAS, the State Department of Corrections and Lane County desire to cooperate by agreement to provide correctional services within the requirements for an Option II county; and

WHEREAS, the Community Corrections Advisory Committee has developed a plan for the allocation of Community Corrections Act funds for FY 95-96 as approved in Board Order 95-8-8-2; and

WHEREAS, the State Department of Corrections has since increased its total Community Corrections Act dollar allocation to Lane County to include release subsidy funds; and

WHEREAS, the Board of County Commissioners, as the governing board of Lane County may, in accordance with Oregon Revised Statute 294.326(2), appropriate and adjust by resolution unanticipated revenues and expenditures; now, therefore,

**IT IS HEREBY RESOLVED AND ORDERED**, that Lane County enter into, and the County Administrator be delegated authority to sign, an eighteen month Intergovernmental Agreement with the State Department of Corrections for \$2,841,810 to deliver corrections services as outlined in the FY 95-96 Community Corrections Act Plan; and

**IT IS FURTHER RESOLVED AND ORDERED**, that Board Order 95-8-8-2 be amended by increasing the recommended FY 95-96 budget of \$1,828,338 by \$60,000 in release subsidy funds for a revised total of \$1,888,338; and

**IT IS FURTHER RESOLVED ORDERED**, that after holding a required public hearing, the adjustments to the appropriations within the funds shown on the next page are hereby approved for the purpose of implementing the FY 95-96 Community Corrections Plan:
