) IN THE MATTER OF NAMING A  
) PRIVATE ROAD HOLLIS LANE  
) (16-04-31 & 17-04-06)

**WHEREAS**, Lane County has jurisdiction for the naming of this private road; and

**WHEREAS**, it is in the public interest for the road to be named at this time; and

**WHEREAS**, the Lane County Surveyor's Office has received a valid petition signed by the City of Eugene, who is the majority landowner of property served by this private roadway, requesting that this road be named Hollis Lane in honor of Mr. Orlando Dean Hollis a long time benefactor of the City of Eugene Mahlon Sweet Airport; and

**WHEREAS**, authority was granted to Lane County by ORS Chapter 215, Lane Code Chapter 15 and the Lane County Home Rule Charter regarding procedures and requirements relating to the naming and renaming of roads in Lane County; and

**WHEREAS**, legal notice has been provided by publication and service to abutting owners, in accordance with Lane Manual 15.025; and

**WHEREAS**, on August 13, 1997, the Lane County Board of Commissioners conducted the First Reading of this Ordinance, and on September 3, 1997 conducted the Second Reading and held a public hearing to consider the road naming ordinance; and

**NOW, THEREFORE**, the Board of County Commissioners of Lane County ordains as follows:

1. That the private road as shown on Attachment 'A', attached hereto and made a part hereof by this Ordinance, is to be named Hollis Lane.
2. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the renaming portions.

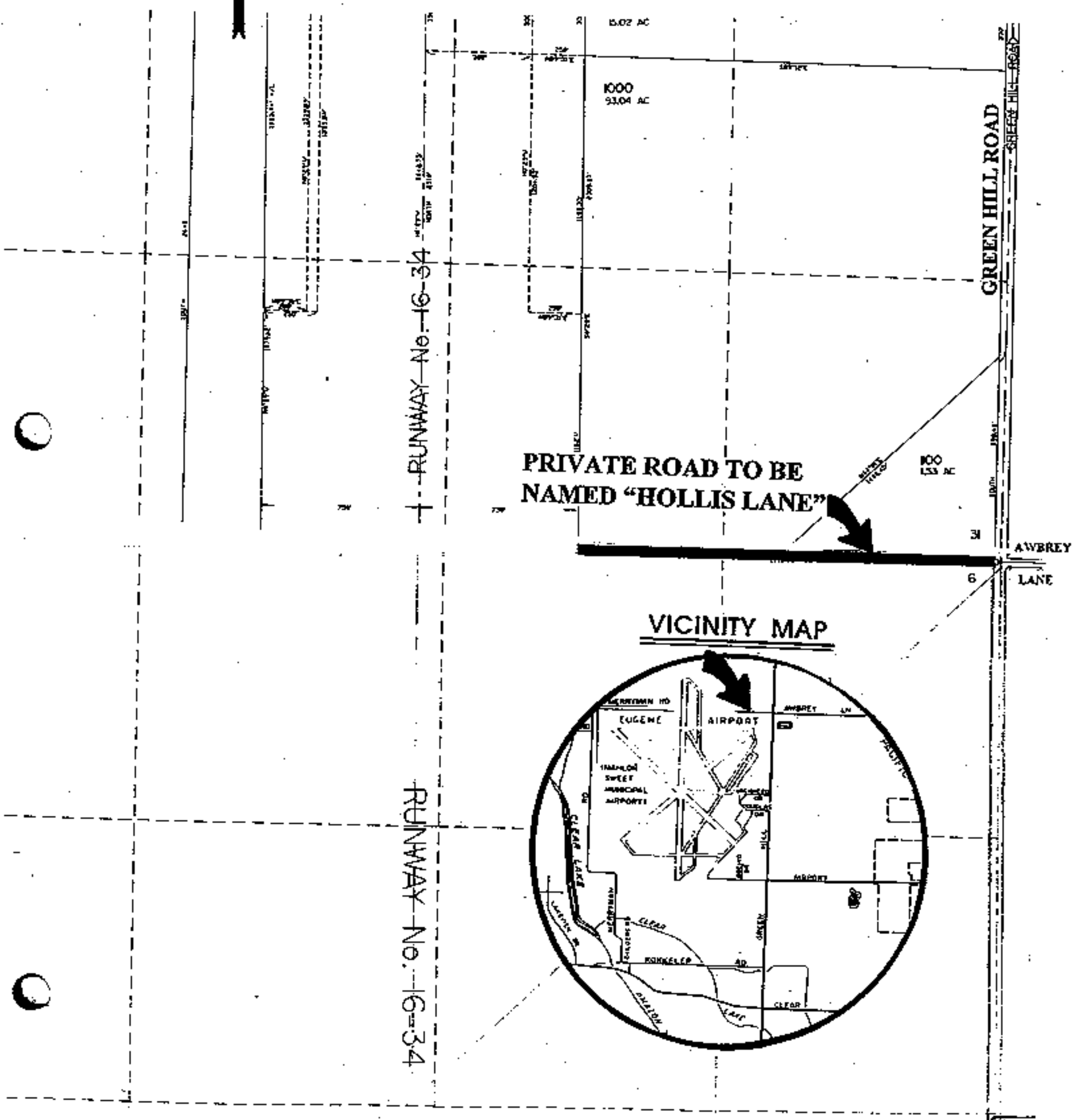

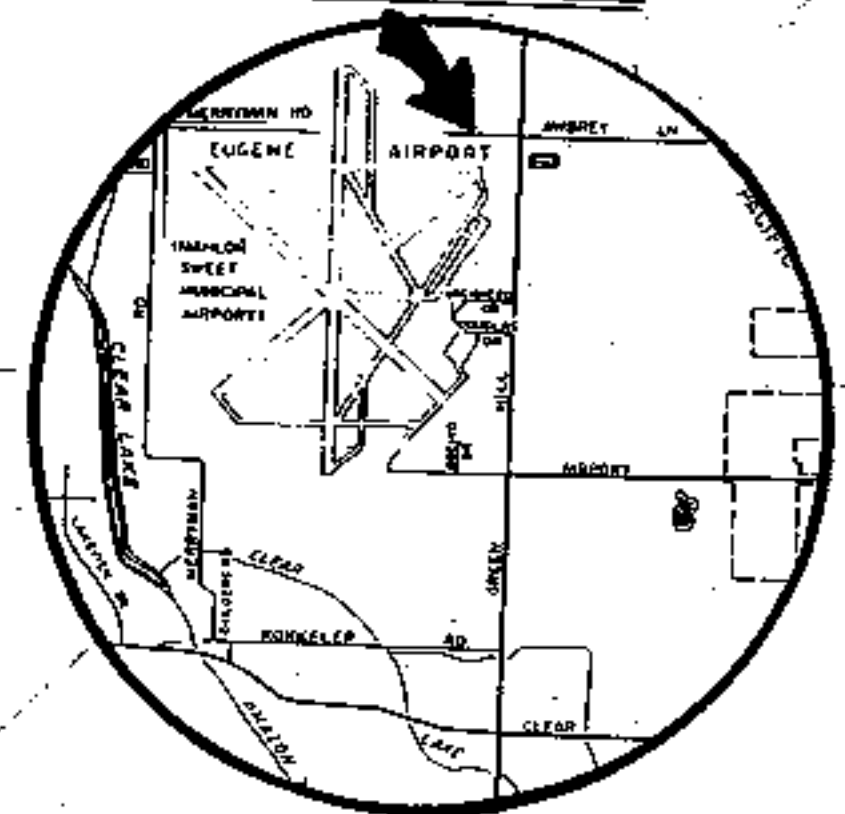
