ORDER NO. 00-10-11-9 IN THE MATTER OF APPOINTING TWO POOLS OF BOARD MEMBERS WHO MAY BE SELECTED BY THE COUNTY CLERK TO SIT ON THE BOARD OF PROPERTY TAX APPEALS

WHEREAS, the county governing body shall appoint one pool of non-office holding resident members representing the Board of Commissioners to act as Chair for any Board of Property Tax Appeals, and one pool of non-office holding residents of the county who are not employees of the county or of any taxing district within the county as prescribed under ORS chapter 309, **and**

WHEREAS, this matter having been fully considered; and upon review by Commissioner Peter Sorenson with input from Annette Newingham, Chief Deputy County Clerk for the appointment of members of the Board of Property Tax Appeals; **and**

WHEREAS, appointment of the pools for the Board of Property Tax Appeals is mandated by ORS chapter 309; **and**

WHEREAS, the newly filed pool of names shall become effective upon approval of this board order, **now**

THEREFORE IT IS HEREBY ORDERED that the following named individuals be appointed to serve as members on the 2000-01 Board of Property Tax Appeals for a term pursuant to ORS 309.020; **and**

IT IS FURTHER ORDERED that this Order shall be entered in the records of the Board of County Commissioners of Lane County.
