WHEREAS, the Bureau of Land Management (BLM) has requested that Lane County (County) relinquish Recreation and Public Purpose Act Leases for Whitewater (Lease No. ORE 06095) and Martin Rapids (Lease No. ORE 011226) County Parks; and

WHEREAS, County has not routinely maintained the parks for the last 20 years; and

WHEREAS, the Parks 2005 Plan recommends that Whitewater and Martin Rapids County Parks be returned to the BLM; and


WHEREAS, BLM desires to maintain the parks for public access to the McKenzie River; and

WHEREAS, it is in the best interest of the County to return the parks to the BLM; and

NOW THEREFORE BE IT ORDERED that County relinquish Lease No. ORE 06095 Whitewater County Park and Lease No. 011226 Martin Rapids County Park as requested by the BLM and it is further

ORDERED that the County Administrator be authorized to sign the relinquishment agreement(s) in similar form as the agreement attached as Exhibit 1.
