) GIRLS COMMUNITY INTENSIVE RESIDENTIAL  
) TREATMENT, \$138,408; DETOXIFICATION SER-  
) VICES, \$107,020; ACUPUNCTURE SERVICES,  
) \$60,000; WAIT-LIST REDUCTION PROGRAM,  
) \$98,550; ALCOHOL AND DRUG FREE HOUSING  
) COORDINATOR, \$74,340; AND RENTAL ASSIST-  
) ANCE FOR DRUG-FREE HOUSING, \$109,140.

WHEREAS, the state Office of Alcohol and Drug Abuse Programs has released a request for grant proposals to fund substance abuse treatment system enhancements and housing for alcohol and drug abuse clients; and

WHEREAS, the grant funds will be awarded to counties with additional projects as requested in the 1999-2001 county Implementation Plans as well as awarded to develop or provide client access to alcohol and drug free housing; and

WHEREAS, Lane County did submit a plan identifying additional services needing support if funds became available; and

WHEREAS, a planning process was conducted to determine which of the services are still needed and what other projects available for alcohol and drug free housing are needed; and

WHEREAS, a recommendation was made and accepted by the Mental Health Advisory Committee; and

WHEREAS, proposals have been developed and must be forwarded to the Office of Alcohol and Drug Abuse Programs for review and possible award; now therefore it is hereby

ORDERED that the Board of County Commissioners authorize the county administrator to sign the proposals: Girls Community Intensive Residential Treatment at \$138,408; Detoxification Services at \$107,020; Acupuncture Services at \$60,000; Wait List Reduction Program at \$98,550; Housing Coordinator at \$74,340; Alcohol and Drug-Free Housing Plan Preparation Funding at \$10,000; and Rental Assistance for Alcohol and Drug-Free Housing at \$109,140.
