Chair Ellie Dumdi presided with Steve Cornacchia, Marie Frazier, Jack Roberts and Jerry Rust present. Judy Haldeman, Recording Secretary.

1. HEARING DATE FOR MASS GATHERING PERMIT

Dumdi stated that this meeting had been called to address the issue of the scheduling of a hearing for the mass gathering. She stated that the land use application for a temporary use permit was filed on January 31, 1992. The first hearing was scheduled for February 20, though a postponement was requested by the applicant. A mass gathering permit was filed on March 16 and a hearing was scheduled for May 11 but due to conflicts, this date was changed to May 20. There have been a number of requests to speed up that date and some requests to continue with that date; as a result, the Board will discuss the date tonight.

Stan Petrasek, Manager of Environmental Health, stated that he should have a draft of a permit ready by April 24. He stated that he is still waiting for referrals from the health officer, the Fern Ridge Fire District and from the Sheriff's Office. Bill Van Vactor, County Council, asked when the report with the referrals would be ready. Petrasek stated that it should be completed by May 1 if all referrals are delivered by April 30. Van Vactor stated that it may be difficult to hold the hearing prior to May 7 and still comply with the legal notice requirements. The Board discussed the date for the hearing given all of the factors which need to be considered. MOTION: To notify the City of Veneta, Fern Ridge School District No. 28J, State of Oregon Department of Forestry (Western Lane Division), State of Oregon Highway Division, State Police, Lane County Food Facilities and Handlers Permits, Lane County Building Official, Lane County Public Works, Lane County Waste Management, Lane County Parks and the Corps of Engineers and request referrals from these agencies. Roberts MOVED, Frazier SECONDED. VOTE: 5-0. The hearing will remain on May 20, as scheduled.

There being no further business, this meeting adjourned at 5:30 p.m.
