Whereas, on July 5, 1994, Jeffrey R. Turk, Property Management Officer 2, Lane County Department of Human Resources & Management Services, opened proposals for Food and Vending Services (CP 93/94 - 13); and

Whereas, TIFFANY FOOD SERVICE submitted the most competitive proposal for providing the service; NOW THEREFORE BE IT

ORDERED that the proposal received from TIFFANY FOOD SERVICE be accepted at the commission rate shown on Attachment A; and it is further

ORDERED that a non-exclusive contract be executed consistent with the terms included on the specimen contract included in the Request for Proposal except that the contract period shall be for eighteen (18) months, with the opportunity for an 18 month renewal if performance, as measured at the end of 12 months, demonstrates clear progress toward increased revenues; and it is further

ORDERED that, following receipt of the contractor's Performance Bond and certificate of required insurances, the County Administrator be authorized to sign the contract.
