Lenz walked away from the custody of the Sheriff's Office early this afternoon while on a work crew.

Lenz was serving a 360 day sentence at the Forest Work Camp for Criminal Mischief 2 (Probation Violation, Probation Revoked) and Stalking-Misdemeanor (Probation Violation, Probation Revoked). He began serving the sentence on 11/05/07.

Lenz left the work crew sometime between 1:15 PM and 1:42 PM. He was last seen wearing blue jeans, an orange hat and t-shirt, a navy blue long sleeved button up shirt, a blue denim jacket all stenciled with "INMATE FWC". He was also wearing a pair of brown leather boots.
