DETAILS:

The Lane County Sheriff's Office with the assistance of the Eugene Police Department's SWAT Team served a search warrant this morning. Sheriff's Office investigator's believed meth and marijuana was being dealt from the residence.

Several people were at the residence at the time the warrant was served, to include a small child.

Meth, Marijuana, and drug paraphernalia were seized and 3 people were arrested.

Investigators believe the 2 inmates that escaped from the Forest Work Camp last week may have ties to the individuals arrested, and this residence. FWC clothing and ID cards were found during the search.

Michael Glenn Bailey is still at large after walking away from the Forest Work Camp on Sunday 12/10/06. Jonathan Sebastian Crawford was arrested last week and lodged in the Lane County Jail.
