DETAILS:

On 11/18/11 at about 12:30 PM the Sheriff's Office received a 9-1-1 call from the resident of 34120 Cloverdale Road. The caller advised that there was an unknown man on her driveway armed with a handgun and firing rounds. The caller's husband confronted the man and the man pointed the firearm directly at him. The suspect was observed standing on Cloverdale Road firing two rounds from the firearm toward the west. The suspect then fled that location in a blue 4D vehicle (vehicle has since been located and recovered).

While Sheriff's Deputies were responding to this call we received another call from the resident of 82899 Brookhurst Street, Creswell. The address shares a property line with 34120 Cloverdale Road. This caller advised that a male suspect had broken into his neighbor's house had stolen a handgun. When confronted by people at 82899 Brookhurst regarding the burglary the suspect, Rodakowski, assaulted one female resident, pointed the stolen firearm at a male resident, then fled east through the backyard onto the property of 34120 Cloverdale. Rodakowski is known to the residents at 82899 Brookhurst. This caller also advised that the suspect had left the area in the blue 4D vehicle.

Sheriff's Deputies had just arrived on Brookhurst Street at 12:52 PM when a third 9-1-1 call was received. This call advised that there was a male subject armed with a handgun in the parking lot of the apartments at 4550 Franklin Boulevard. The caller advised that there was a blue 4D vehicle parked nearby.

Sheriff's Deputies assisted by Springfield Police converged on the area of 4550 Franklin Boulevard. Rodakowski was observed fleeing the parking lot westbound on 19th Street on a bicycle. Once he realized that there was a Sheriff's Deputy and a Springfield Police Officer waiting for him near 19th and Nugget he jumped a fence and continued into the field south of 19th, east of James Park. He was subsequently taken into custody in this same field. After being transported to the Sheriff's Office for an interview he was lodged at the Lane County Jail on the following charges:

Burglary I, Theft I
(82893 Brookhurst Street, Creswell)

Assault IV, Menacing with a Firearm, Unlawful Use of a Weapon
(82899 Brookhurst Street)

Menacing with a Firearm, Unlawful Use of a Weapon x 2
(34120 Cloverdale Road, Creswell)

Assault II, Felon in Possession of Firearm, DUII
(4550 Franklin Boulevard, Eugene)
