ORDINANCE NO. PA 1182

-) **IN THE MATTER OF NAMING AN**
-) **UNNAMED PRIVATE ROAD, SPIRIT**
-) **VALLEY DRIVE (18-04-32 & 19-04-05)**

WHEREAS, the Lane County Surveyor's Office has received a valid application signed by the landowners of this private roadway, requesting that said roadway be named Spirit Valley Drive; and

WHEREAS, it is in the public interest for the road to be named at this time; and

WHEREAS, Lane County has jurisdiction for the naming of this private road; and

WHEREAS, the private road begins at a point on Sarvis Berry Road, and runs in a southerly and westerly direction approximately 0.36 mi. serving five separate parcels of land; and

WHEREAS, the proposed name, Spirit Valley Drive, meets all the criteria in Lane Manual Chapter 15, except for 15.020(3)(a) "Name limited to...one word"; and

WHEREAS, authority was granted to Lane County by ORS Chapter 215, Lane Code Chapter 15 and the Lane County Home Rule Charter regarding procedures and requirements relating to the naming and renaming of roads in Lane County; and

WHEREAS, legal notice has been provided in accordance with Lane Manual 15.025; and

WHEREAS, on October 30, 2002, the Lane County Board of Commissioners conducted the First Reading of this Ordinance, and on December 4, 2002, conducted the Second Reading and held a public hearing to consider the road naming ordinance;

NOW, THEREFORE, the Board of County Commissioners of Lane County ordains as follows:

1. That the private road as described above and shown on Attachment 'A', attached hereto and made a part hereof by this Ordinance, is hereby named Spirit Valley Drive.
2. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions.

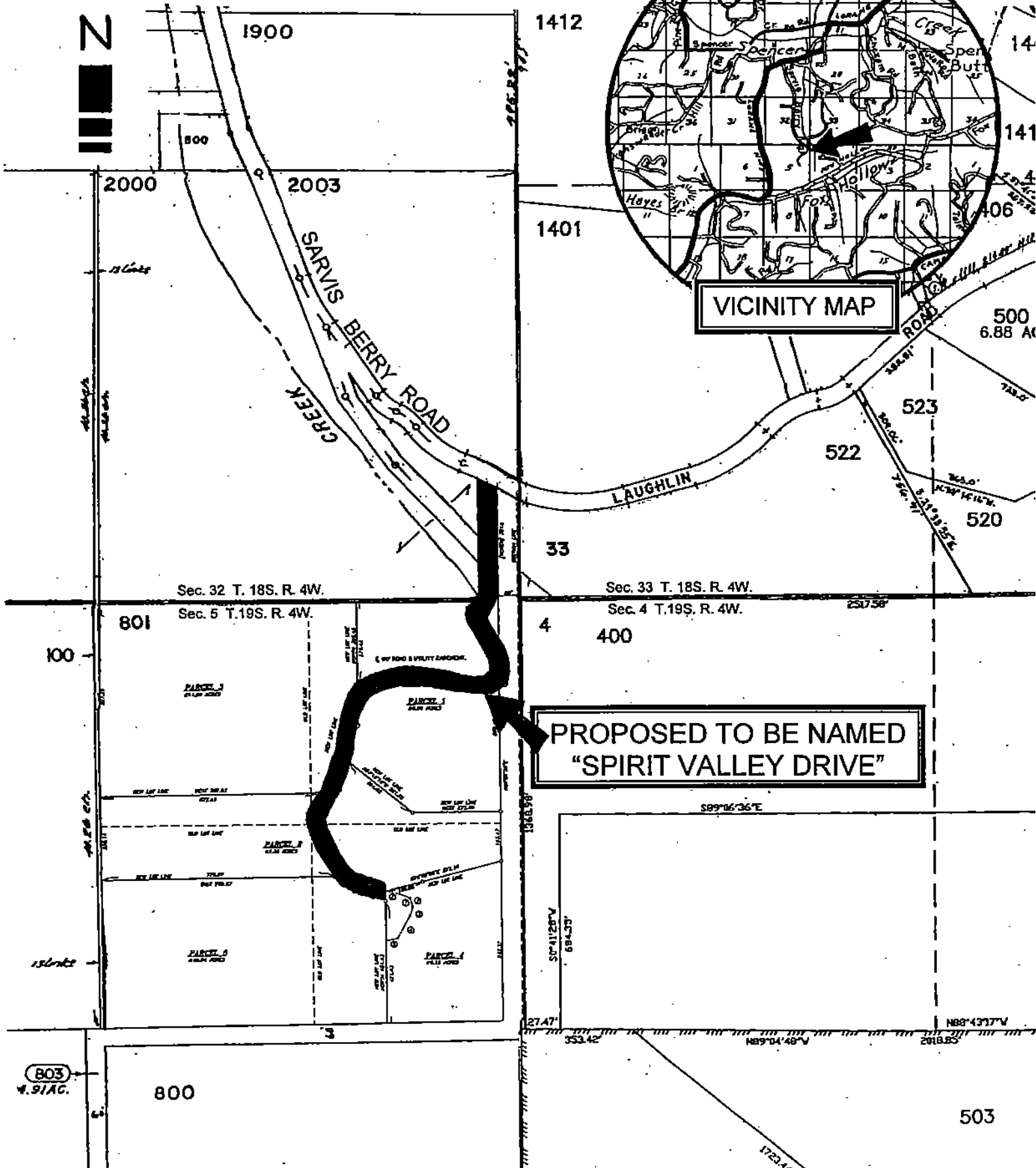
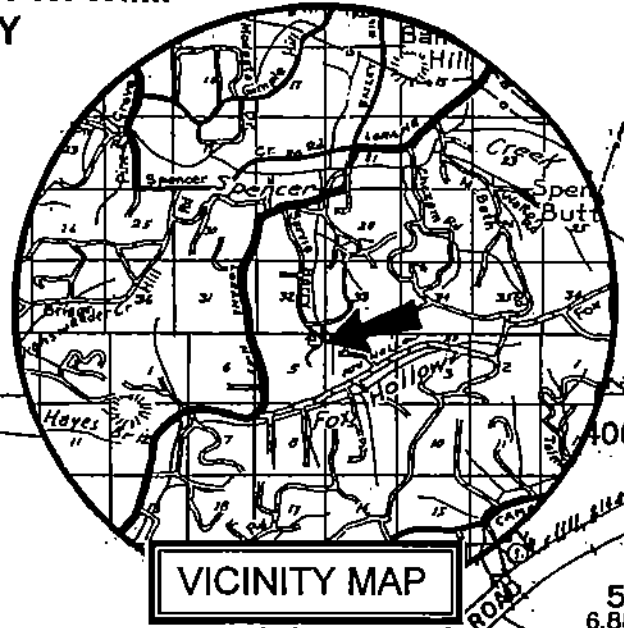
