THIS MATTER, now coming before the Board of County Commissioners for Lane County, Oregon as emergency business, it appearing that the westerly 0.16 mile portion of Duncan Island Road is no longer needed as part of the County's road system; and

WHEREAS, Resolution, Notice of Hearing and Order No. 02-5-8-17 initiated proceedings to withdraw County Road Status, and ordered a public hearing date set for July 3, 2002 at 1:30 PM; and

WHEREAS, the Board of Commissioners have decided to revise this date to August 14, 2002; and NOW THEREFORE, IT IS HEREBY

ORDERED, that August 14, 2002 be established as the date for conducting a public hearing regarding the proposed withdrawal of county road status (but not the public road status) from a portion of Duncan Island Road, as described in the Resolution, Notice of Hearing and Order No. 02-5-8-17, and that the said hearing be held at 1:30 p.m. in Lane County Courthouse, 125 E. 8th Avenue, in Eugene, Lane County Oregon; and it is further

ORDERED, that notice of the public hearing be provided by service in accordance with ORS Chapter 368.401 to 368.426.
