

A refund is being issued to MBM Group for tax year 2001-2002 on account 1570652. The property is located at 460 North Danebo Avenue; Eugene, Oregon.

The referenced account is the appraisal responsibility of the Oregon Department of Revenue - Industrial Valuation Section. Per the Department of Revenue, portions of the equipment were sold as of the January 1 assessment date. The Department of Revenue has since submitted new valuation transmittal sheets correcting this error and our office has reduced the value and tax resulting in a refund.

In October, 2001, the Department of Assessment and Taxation sent a tax statement for the fiscal year 2001-2002 to the owner of record for the property, MBM Group LLC. The taxpayer sent a full payment on November 15, 2001. The payment was processed by the Department of Assessment and Taxation on November 27, 2001.

Due to the above circumstances, the Department of Assessment and Taxation needs to refund per Oregon Revised Statute 311.806(b) the tax amount of \$12,117.96 and statutory refund interest in the amount of \$1,332.98 computed through October 15, 2002 for a total refund of \$13,450.94. The refund is being issued to the owner of record MBM Group LLC.
