



WHEREAS, it is required that the Judge of Oakridge Justice Court be available for duty seven ~~days a week; and~~

WHEREAS, Judge Charles Navarro of the Oakridge Justice Court may not be able to serve at certain times because of other obligations or potential conflicts of interest; and

WHEREAS, the Board of Commissioners finds that the public interest requires that a Justice Pro Tempore be appointed during the Judges' absence; and

WHEREAS, ORS 51.260 permits the appointment of a sitting justice of the peace from any county justice of the peace district within the State of Oregon, or person qualified for election, to serve as justice of the peace pro tempore, the appointment not to exceed one year.

NOW THEREFORE IT IS ORDERED that Judge Jad Lemhouse be appointed as Justice Pro Tempore to the Upper Willamette Court, to be assigned in writing by Judge Charles Navarro during any absence of the Judge from Friday, November 4, 2003 through Saturday, November 6, 2004.
