(ASSESSMENTS FOR IMPROVEMENTS TO
(MARCOLA ROAD BETWEEN MILEPOST 10.49
(AND MILEPOST 11.75 AND SATISFACTION OF
(PENDING LIENS AGAINST ADJACENT
(PROPERTIES.

WHEREAS, construction of improvements to Marcola Road began in the Spring of 2003, and the assessable items have now been completed and inspected. In accordance with ORS 371.640, the project was approved as constructed solely for the purpose of levying final assessments by the County Engineer on February 17, 2004; and

WHEREAS, in accordance with Lane Manual Chapter 21.149(2), the Public Works Director accepted the project solely for the purpose of levying final assessments on February 19, 2004; and

WHEREAS, the Board, by Resolution and Order Number 00-11-29-5, resolved to award a Community Development Grant under the Community Development Road Improvement Assistance Program for the construction of sidewalks along Marcola Road in an amount not to exceed \$125,000.00; and

WHEREAS, by Order No. 02-12-11-3, the Board accepted the Director's Report for improvements of Marcola Road, Railroad Lane to Wendling Road, and ordered that the amount of the Community Development Grant be proportioned to the abutting owners to offset the costs associated with the Lane County Special Assessment Program; and


WHEREAS, certain adjacent properties were ordered to be subject to a lien by Board Order No. 03-1-21-17; and

WHEREAS, the total amount of the final assessments for Marcola Road from Railroad Lane to Wendling Road, was determined to be \$99,507.27, which includes 25% engineering and administrative costs, and which is less than the amount of the Community Development Grant; NOW THEREFORE

BE IT ORDERED that the Board finds the assessments for improvements to Marcola Road, Railroad Lane to Wendling Road, are hereby determined to be at no cost to the abutting owners, each of which is shown on the attached Exhibit A;

BE IT FURTHER ORDERED, in accordance with ORS 371.650(1), that this order shall be recorded and filed with the County Clerk along with the notice of pending liens recorded against the abutting owners as shown on the attached Exhibit A, and that said pending liens shall thereby be satisfied.
