
WHEREAS, Lane County is amending a contract with Motorola for purchasing additional equipment with the grant funds.

I. MOTION

MOVE TO APPROVE THE ORDER IN THE MATTER OF DELEGATING AUTHORITY TO THE COUNTY ADMINISTRATOR TO EXECUTE THE SPECIFIC CONTRACTS AND INTERGOVERNMENTAL AGREEMENTS LISTED IN THE COVER MEMO RELATED TO THE STATE HOMELAND SECURITY PROGRAM AND LAW ENFORCEMENT TERRORISM PREVENTION PROGRAM GRANTS

ISSUE/PROBLEM

Should Lane County Board of Commissioners delegate authority to the County Administrator to execute those listed contracts related to the Homeland Security grants.

II. DISCUSSION

A. Background

Lane County collaborated with five (5) law enforcement agencies on the FY 2004 Law Enforcement Terrorism Prevention Program (LETP) Grant application and thirteen (13) agencies on the FY 2004 State Homeland Security Grant (SHSG) application. Grant funds in the amount of \$1,212,600 were awarded by the Office for Domestic Preparedness administered by the Criminal Justice Services Division/Oregon State Police.

Board Order 04-6-30-3 authorized acceptance of \$212,600 from the FY 2004 Law Enforcement Terrorism Prevention Program Grant (LETP) and \$1,000,000 from the FY 2004 State Homeland Security Grant (SHSG), and delegated authority to execute the grant documents.

Grant documents, LETP and SHSG, are between Lane County (grantee) and Department of State Police (grantor). Exhibits A (LETP) and B (SHSG) list the approved equipment per agency authorized to be purchased and reimbursed by the grant funds. Lane County will execute Contracts and Intergovernmental Agreements with all collaborating agencies (subgrantees), and will coordinate the requests for reimbursement.

In order for collaborating agencies to receive portions of the grant funds, Lane County, under the LETP Grant, is preparing Intergovernmental Agreements with City of Cottage Grove (\$54,774) and City of Junction City (\$66,847) in amounts exceeding the County Administrator's delegated authority to execute.

Lane County, under the SHSG, is preparing Intergovernmental Agreements and Contracts with Eugene Water & Electric Board (\$99,660), Springfield Fire & Life Safety (\$69,760), Sacred Heart Medical Center (\$77,048.50) and McKenzie Willamette Hospital (\$85,056.68) in amounts exceeding the County Administrator's delegated authority to execute.

Of the \$1,000,000 grant under the SHSG, the Sheriff's Office itself, was awarded \$496,940.82.

The Sheriff's Office wants to utilize its portion of the SHSG Grant to purchase additional communication equipment through Motorola. This additional equipment is covered by a state price agreement with Motorola. Accordingly, no additional competitive selection is required. Since Lane County through the Sheriff's Office currently has a contract with Motorola covering certain radio equipment, the Sheriff's Office wants to amend the existing contract to cover this additional communication equipment.

Amendment to the Motorola contract to order the communication equipment with grant funds will amend the contract an additional \$496,940.82 bringing the total contract amount to \$878,355.22.

B. Alternatives/Options

1. Adopt the order to delegate authority to execute those listed Intergovernmental Agreements and Contracts related to the LETP and SHSG Grants.
2. Do not approve the order.

C. Recommendations

Recommends Board approval of proposed Board Order.
